Dr. Janelle Allison received her M.S. in applied behavior analysis from Florida Institute of Technology in 2010. She received her Ph.D in behavior analysis at Florida Institute of Technology in 2015. Dr. Allison has more than 15 years of experience in the field of behavior analysis and has worked in the areas of online behavior analytic curriculum development and supervision since 2008. Her professional experience includes autism early intervention program case management, as well as the assessment and treatment of early childhood compliance problems, severe behavior, and pediatric mealtime related problem behavior. Dr. Allison's professional interests include online curriculum development, instruction, and supervision, relational frame theory and its application to complex human behavior. Dr. Allison's research interests include the assessment and treatment of pediatric feeding disorders, severe behavior disorders, and child compliance, as well as the use of the Implicit Relational Assessment Procedure to examine complex human behavior.

Marina Azimova has spent the last 20 years working in the field of Applied Behavior Analysis and Behavioral Health as a BCBA in Pennsylvania, Connecticut, Germany, Russia, Kazakhstan, and Taiwan. She has knowledge and experiences in the areas of behavioral assessment and intervention including functional assessment/analysis, antecedent intervention, reinforcement-based strategies, and a variety of instructional procedures (e.g., DTT, precision teaching, verbal behavior, functional/living skills, and task analysis) for students with autism and related disabilities. She has worked in various treatment settings to include intervention and on both public and private school throughout Connecticut and Pennsylvania serving students with ASD. Marina has also served as a clinical consultant at the Deveraux Foundation working with adult population. She started several ABA classrooms based in public schools in Moscow, Russia and the Republic of Kazakhstan. Marina Azimova participated in translation from English and publishing "White Book" in Russian Federation in 2016. She has also previously served as the Clinical Director at Milestones Achievement Center in Wyoming, Pennsylvania where she handled both clinical and administrative duties, which included overseeing program development and programming for specialized classrooms for individuals with autism, supervising and training teachers and teacher assistants within the program, scheduling, quality monitoring, and performance evaluations. John Borrero, Ph.D., BCBA-D University of Maryland, Baltimore County (UMBC)



Dr. Borrero received his Ph.D. from the University of Florida (UF) and is now Associate Professor of Psychology at the University of Maryland, Baltimore County (UMBC). At UMBC, Dr. Borrero serves as the Director of the Applied Behavior Analysis masters track, and as Coordinator of the BACB Verified Course Sequence. At UF, Dr. Borrero received training in the assessment and treatment of severe problem behavior, but thanks in large part to his mentors; Borrero also conducted research in the nonhuman animal laboratory. Borrero's experiences and training with vulnerable populations strengthened his appreciation for readily exportable assessment and interventions strategies. Borrero's experiences and training in the nonhuman animal laboratory strengthened his appreciation for the mechanics of basic science, and introduced him to the importance of translational science. In recent years, Borrero's research has drawn heavily from basic behavior-analytic findings, and these projects have been carried out in the "human operant laboratory." The overarching theme of these projects has been to enhance behavioral intervention, in application. Borrero previously served as an Associate Editor for the *Journal of Applied Behavior Analysis* and *Behavior Analysis in Practice*.
